



Washington, D.C. — May 23, 2017 — With details of the President’s FY18 budget now released, the Large Countywide and Suburban District Consortium—a network of nineteen of the nation's largest and most highly-regarded school districts spanning thirteen states from Washington to Florida—reiterates its concerns with the administration’s proposal to make dramatic cuts to public education funding.

"Our schools, our teachers, and, most importantly, our students deserve our best as a nation," said Consortium Chair Dr. Aaron Spence, Superintendent of Virginia Beach City Public Schools (VA). "Cutting these federal funds would make it significantly harder for school districts to deliver on the promise of public education. The proposed cuts are particularly troubling because the eliminated funding is primarily targeted to support our most disadvantaged students and schools. The last thing we should do is take resources away from those who need them most."

Consortium Past Chair J. Alvin Wilbanks, CEO/Superintendent of Gwinnett County Public Schools (GA), stated: "As local education leaders, we take seriously our obligation to taxpayers to use all public funds responsibly. We support efforts to improve how we invest those limited funds, but we cannot endorse making deep cuts to essential programs, such as improving classroom instruction and school leadership; support for career and technical education; or funding for afterschool programming."

The Consortium strongly urges Congress to reject these harmful cuts and instead appropriate sufficient funding to support the critical work of our public school systems.
